PREAMBLE:

In the Government Order read at (2) above, certain clauses of Standard Tender Document were modified to ease the difficulties expressed by Public Works Department in implementation of the Document prescribed vide Government Order read at (1) above. The Government Order dated 14.10.2008 specifies that the Earnest Money Deposit may be in the form of Banker's Cheque/ Demand Draft/ Pay Order/ cash or specified Small Saving Instruments. The Water Resources Department (Minor Irrigation) has suggested to include Fixed Deposit Receipt(FDR) as one of the form of depositing Earnest Money Deposit. The proposal is examined and hence the following Order.

Government Order No. FD 1 PCL 2010, dated: 23.09.2010

Under the circumstances explained in the preamble, in serial no. 08, column 03 of Government Order dated 14.10.2008 the following shall be and shall always be read after the last word:

' or Fixed Deposit Receipt (FDR) subject to following condition:

- (i) Maturity date of FDRs issued by the Bank should be beyond the expected date of finalisation of the tender.
- (ii) A control mechanism should be adopted by the Tender Inviting Authority by keeping a register for entering the security maturity dates, amount and tender value, status of tender etc. to ensure that FDRs and other security instruments do not mature before the expected date of finalisation of a tender.'
